Background

ECP-2 is the second stage of the CRU's development of enduring connection policy in Ireland. On the 10th June 2020 the CRU published their decision¹ on ECP-2, which set policy for at least three annual batches of connection offers (ECP 2.1, ECP-2.2, and ECP-2.3). Subsequently, the CRU published their decision on ECP-2.4², which set policy for an additional batch of connection offers (ECP-2.4). On 25th September 2024 the CRU published their decision³ on the Electricity Connection Policy – Generation and System Services (ECP-GSS) which will apply to onshore renewable and conventional generators, storage, and other system services technology projects connecting to the electricity system. In this decision paper, the CRU have directed the System Operators to process a final batch under the existing ECP-2 policy (ECP-2.5).

The application window for ECP-2.5, closed on November 30th 2024. The System Operators (SOs) have used the ECP-2 decision paper¹, ECP-2 ruleset⁴ and the subsequent ECP-2.4 decision paper²2 above to determine which applicants have been initially successful in making the list of 65⁵ projects due to receive connection offers under Category A.

This report contains the initial list of applicants that will be processed under Category A as part of the 2024 ECP-2.5 batch following payment of the balance of application fees to the relevant SO. As per the decision paper, the first 25 projects in category A were selected on the basis of renewable output, with the projects having the largest volume of renewable GWhrs/yr generated being granted the highest priority. The subsequent 40 projects were selected in order of planning permission grant date. There is a cap of 10 storage and other system service technology projects in each ECP-2 batch - apart from these projects, all eligible applications to ECP-2.5 were accepted into the Category A batch.

Please note that the projects in Category A may change should projects not proceed with their application, or no longer be deemed eligible.
